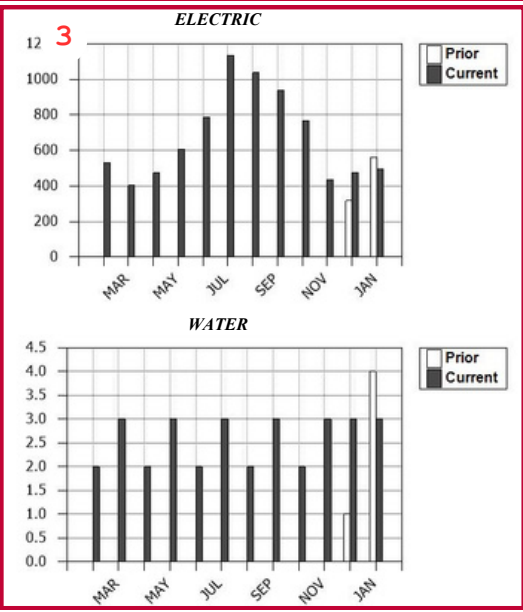

- Beginning and ending date of the billing cycle, and how many days the cycle was total.
- Date that the bills were generated/printed.
- Graphs showing this year and last year's usage.
- Previous reading from the last billing date.
- Present reading taken for this billing date (usually around the 15th).
- Difference between the current bill reading and the previous bill. Shows this month's usage.
- Last month's payment activity.
- Water charge based on usage and billed by 1,000 gallons.
- Monthly customer charge for having the electric service.
- Electric charge, based on usage.
- This charge accounts for variable costs related to generating and delivering electricity, including fuel and purchased power.
- Water tax collected for the State of Kansas.
- Sewer charges are based on the average amount of water used during January, February, and March.
- Fee to help maintain our stormwater system.
- A fee based on the electric usage pertaining to infrastructure costs.
- City, County, and State sales tax.

**FAQ**

- Why is my sewer charge based on an average of the first three months of the year?**
- Sewer charges are averaged during the winter months to ensure fairness. This prevents customers from being charged sewer fees for water used outdoors, such as watering lawns or filling pools, which does not enter the sewer system.
- When are late fees applied, and when does disconnection occur?**
- Bills are considered delinquent at 4:30 PM on the 16<sup>th</sup>. Penalties will be applied at that time. Disconnections occur on the first business day of the following month if payment has not been received.
- What charges on my bill are subject to tax?**
- Residential customers are taxed only on electric charges. Commercial and industrial customers are taxed on both water and electric charges.
