## ORDINANCE NO. 1824

AN ORDINANCE OF THE GOVERNING BODY OF THE CITY OF WAMEGO, KANSAS, AMENDING PARAGRAPH 15-306 OF THE CODE OF THE CITY OF WAMEGO, KANSAS, ESTABLISHING NEW CHARGES FOR WATER OBTAINED FROM THE CITY OF WAMEGO MUNICIPAL WATER SYSTEM; AND REPEALING ORDINANCE NO. 1783, 1799 AND ALL OTHER ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WAMEGO, KANSAS:

Section 1. That Paragraph 15-306 of the Code of the City of Wamego, Kansas, be and the same is hereby amended to read as follows:

15-306 SCHEDULE OF RATES. All water bills shall be paid monthly on or before the 16<sup>th</sup> day of the month following the service rendered. For the purposes of this article, "customer" shall mean the water service account holder of record. Any water service account holder assigned a city water meter is a customer. The following rates shall be charged for each meter serving a customer:

<u>City Customers</u> - The following is hereby established as rates for water used by all customers within the City, for water obtained from the municipal water system:

Customer charge: \$22.00 per month.
0-9,999 gallons at \$3.00 per 1,000 gallons
10,000 gallons -19,999 gallons at \$3.50 per 1,000 gallons
All over 20,000 gallons at \$4.00 per 1,000 gallons

<u>Rural Customers</u> - The following is hereby established as rates for water used by all customers outside the City, for water obtained from the municipal water system:

Customer charge: \$44.00 per month.
0-9,999 gallons at \$6.00 per 1,000 gallons
10,000 gallons -19,999 gallons at \$7.00 per 1,000 gallons
All over 20,000 gallons at \$8.00 per 1,000 gallons

Section 2. That the schedule of rates in Paragraph 15-306 of the Code of the City of Wamego, Kansas, as amended under Section 1 of this Ordinance, shall take effect and be in force after publication and shall be applicable for the billing due January 1, 2026, and thereafter.

Section 3. That Ordinance No. 1783, 1799 and all other Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

Section 4. That this Ordinance shall take effect and be in force from and after its passage and publication in the City's official paper, The Times, Pottawatomie County.
